In the tenure of this Administration from July,2018 to July 2021, I can look back and see the following enhancements to David V. Moore Grand Guild of Ohio with your help the following: We reconstructed all forms to reflect the name of David V. Moore Grand Guild, Heroine of Templar Crusades, State of Ohio and Its Jurisdiction, P.H.A., Inc. We secured a bond to cover the Officers of the Grand Princess Captain, Grand Secretary and Grand Treasure. The Website Committee chaired by Grand Second Lieutenant, Princess Barbara Hudson Banner is up and running. We were then able to make all forms available for download. It is continually being worked on to include the files into cloud. The Trustees voted to rent space in the Headquarter in Columbus, Ohio for one hundred (\$100.00) dollars per year. Moore Grand Guild under the guidance of the Grand Secretary, Honorary Past Grand Princess Captain, Princess Janice M. Bostic.

New Constitution and By-Laws, chaired by Past Grand Princess Captain, Princess M. Francine Washington, the Protocol Committee, chaired by Past Grand Princess Captain/ International Grand Princess Commandress, Princess DeNoris Brown and the Ritualistic Committee chaired by Past Grand Princess Captain/International Grand Princess Commandress, Rev. Constitutions and By-Laws

For better participation and growth of David V. Moore Grand Guild, it is recommended that each local Guild be represented in the Grand Guild line beginning with the Assistant Commissary, as this position is usually filled by the outgoing Grand Lecturer.

REASON: The local Guilds make up the Grand Guild and all should have representation In the line.

Yes, some Guilds are smaller in number and may need assist until such time as growth take place, but they contribute to David V. Moore Grand Guild Returns, Taxes and Scholarship, and equal opportunity should await them. It does not mean that they are not equipped with qualified princesses. Should this happen, all line Officers will be wearing red sashes, as they should be.
