To the Princess Captain, Royal Advisor, All Grand Officers Present and Past, Princesses and Sir Knights:

Greetings:

DIRECTIVES – DECEMBER, 2018

Please be advised that Edit-1 dated November 14, 2018 should have stated Directives instead of Edit-1. This is a correction of said document and a continuation of Directives. Therefore, the three listed in that document are to be noted as Directives 1,2, and 3.

WRD#4 Dress Regulations:

Princesses shall wear White long sleeved or $\frac{3}{4}$ sleeved dresses or White skirts and shirt-waist blouses with long or $\frac{3}{4}$ sleeves, or a White suit (no pleats or lace). White capes lined with gold, White and Gold caps, White shoes with low or medium heels, plain White stockings, White gloves (no lace) White purse, and small White jewelry. Princesses shall carry a sword.

WRD#5 Dress Code for Templar Social Functions:

Princess shall wear a Long white dress (long or $\frac{3}{4}$ sleeves, white suit or White blouse long $\frac{3}{4}$ sleeves) and a long White skirt (NO SEQUINS OR BEADS). Plain white stocking; plain White gloves; White shoes (PLAIN PUMP, NO OPEN TOE OR SLING BACK); Small white jewelry (NO DANGLING EARRINGS); Small white plain purse; White Cape lined with gold; and White and gold caps; The Sash and Sword are not to be worn; The dress Cap may be worn in place of the Regulation Cap; (a) Past Grand Princess Captains- white/Purple Cap, (b) Past Princess Captain-White w/Red Cap and All other Princess- white w/Gold Cap. Grand Princess Captain Long White Dress of Choice.

WRD#6 Each subordinate Guild is required to host Ascension Day Service or attend Ascension Day Service hosted by their Commandery (when invited).

DIRECTIVES – DECEMBER ,2018 CONTINUED

- WRD#7** Princesses will not have to wear capes at regular monthly meetings, with the exception of those meetings that are to include inspections or official visits from the Grand Princess Captain, Grand Royal Advisor, or Grand Deputy Lecturer.
- WRD#8** Each subordinate Guild's monthly meeting will include fifteen to thirty minutes of instructions. Membership to receive a copy of all Directives.
- WRD#9** Each subordinate Guild is required to participate in Community Service Projects (i.e. blanket, or clothes for the homeless shelters, visits to nursing homes, hats, scarves, gloves, or socks for schools.) A scrapbook of these activities will be compiled and turned over to the Chairperson for the Golden Guild Award at Grand Conclave.
- WRD#10** The Secretary of each subordinate Guild will serve as the Historian and submit the following information by March 31, 2019 to Princess Mary Harpe as indicated in the November 14, 2018 Directive. The following information should be included: Typed history of the local Guild and First Picture if you have it, list of all Past Princess Captains/Past Royal Advisors with the year they served. Any pictures of Past Grand Princess Captains, and Past Grand Royal Advisors with the year served. List of each Guild, their Officers, date and location where they meet and contact information.
- WRD#11** Application for Dispensations shall be made to the Grand Princess Captain under Subordinate Guilds' Seal.
- WRD#12** The fee shall be three (3) dollars which shall accompany the application. If denied, fee shall be returned.
- WRD#13** All Financial Officers (Secretary, Treasure, Princess Captain) of Subordinate Guilds must be bonded. Check Book in Business form (not personal type checks), effective January, 2019 Meeting
- WRD#14** All Minutes must be in a Bound Book, effective the end of the Audit period in December 2018, which means effective with your January, 2019 Meeting.
